Please note that you are required to bring the following documents at the time of admission at our Institute:

- Provisional Admission letter issued by the Reporting centre (in original)
- Print-out of the locked choices (JoSAA counselling)
- JEE 2017 Admit Card
- JEE 2017 Rank Card
- 12th Class Mark sheet/certificate (Original and self-attested xerox copy)
- 10th Class Mark sheet/certificate (Original and self-attested xerox copy)
- Migration Certificate (original)
- Transfer certificate (original)
- Character certificate (original) must be issued within last six months from the authorized officer (Gazetted officer)
- Gap certificate (if applicable) on stamp paper from notary.
- Medical certificate (As per JOSAA format) in original
- PwD or PH certificate as per JOSAA format (if applicable)
- 5 passport size photographs
- Identity Proof
- Two self-addressed envelopes

Further, the fee structure for SMVD University for the 1st Year is as given below:

Also, the candidates who are eligible for scholarship (For B.Tech. : JEE-Rank (CRL) below 01 Lakh and For B.Arch. : JEE-Rank (CRL - Paper 2) below 03 Thousand) are not required to pay the tuition fee (Rs. 60,000/-) for the first semester at the time of reporting for admission at our institute. (please refer www.smvdu.ac.in for scholarship details).

Although the Tuition Fee is to be paid as a lump sum, however the student can pay the tuition fee semester-wise also (Rs.60, 000/- at time of registration of each semester).

Further, the total fee applicable to be paid at the time of admission shall be the balance amount after deducting the fee already paid to the JOSAA during counselling process.

Candidates who are taking admission in SMVDU in B. Tech. program through JOSAA Counseling having Rank (**JEE-Rank (CRL) below 01 Lakh**) are required to pay the minimum fee as/details below:

The total fee shall be required to pay by two different transactions (one for academic and hostel fee e.g. **Rs. 11,100/-**) second for mess (Rs. 26,200/-) fee in either of the following modes:

- (1) By online payment at www.smvdu.ac.in after registering yourself.
- (2) By two different Demand drafts in favour of “**Registrar-Shri Mata Vaishno Devi University**” payable at Katra. (one for payable academic fee and second for Mess fee)
- (3) By two different NEFT’s or RTGS’s i.e. one for payable Academic and Hostel fee and other for Mess (Rs. 26,200/-) fee at either of the following accounts:
