## **Minimum Qualifications and Experience**

### **1. For The Post Of “BHARTI ARIAN CHAIR PROFESSOR, SMVD University”, for research work in the area of wireless communication, School of Electronics & Communication Engineering.**

#### **1. (A).Academic Qualification:**

- a). B.E. / B.Tech. and M.E. / M.Tech. in relevant branch with First Class or equivalent either in B.E. / B.Tech. and M.E. / M.Tech.
- b). Ph.D., in appropriate discipline. Post Ph.D. publications and guiding Ph.D. students is highly desirable.

#### **2. Work Experience:**

Minimum of 10 years of experience at the level of Professor in the pre-revised PB of ₹. 37400-67000, with AGP of ₹.10,000/-, revised to Academic level 14 as per 7<sup>th</sup> CPC.

#### **3. Additional credentials are to be evidenced by:**

- a. Post-doctoral research output of high standard;
  - b. Awards / honours / recognitions / patents and IPR on products and processes developed / technology transfer achieved; and
  - c. Additional research degrees like, D.Sc., D.Litt., LL.B., etc.
4. Minimum yearly / consolidated API score of 50 per year or 500 for the assessment period, from category III, as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in the AICTE regulations of 2012, as per format attached.

## **CONDITIONS OF EMPLOYMENT FOR FACULTY POSITIONS:**

### **1. Pay Band (Regular):**

**Professor:** Pay Band of ₹. 37400-67000, with HAGP of ₹.12,000/-, revised to academic level 15 with entry pay of ₹.1,82,200/- as per 7<sup>th</sup> CPC.

### **2. Regulatory Bodies:** The Faculty positions in the School of Electronics & Communication Engineering, shall be governed by AICTE norms.

## **GENERAL CONDITIONS [For Faculty Positions]:**

1. Applications for all positions have to be filled Online on the University Website [www.smvdu.ac.in](http://www.smvdu.ac.in).
2. The shortlisting/selection shall be done strictly in accordance with the Orders dated: 03.11.2017 of the Hon'ble Supreme Court of India, in the case of Orissa Lift Irrigation Corp. Ltd. Vs Rabi Sankar Patro & Ors. and the subsequent Public Notices issued vide no. F.No.4-4/2017 (DEB-I) dated: 22nd November 2017, by the UGC, and Public Notice vide no. Advt. No. P&AP/11(03)2017, dated: 2nd December 2017 issued by AICTE in this regard.
3. Shortlisting for Faculty Positions in Engineering Schools shall be done in accordance with AICTE notification issued vide no. F. No. 27/RIFD/Pay/01/2017 – 18, dated: 28<sup>th</sup> April 2017 w.r.t Major / Core Branch of

Engineering / Technology and their relevant / appropriate courses leading to degree in Engineering / Technology for recruitment to teaching positions.

4. Candidates who have been awarded Ph.D. from foreign Universities should enclose "Equivalence Certificates", issued by the Association of Indian Universities, New Delhi, without which their candidature will not be considered and application will be rejected.
5. The medium of instruction in the University is English.
6. The recruitment to the advertised posts shall be carried out in accordance with the guidelines of the relevant regulatory authority.
7. It is made clear to all applicants that the University's "Applications Short-listing Committee" will decide the short-listing criteria which may be much higher than the Minimum Eligibility Criteria laid down by the regulatory bodies.
8. The eligibility of the applicants shall be considered as on their date of application.
9. University reserve the right to withdraw any advertised post at any time without assigning any reason thereof. The right is also reserved with the University either to fill or not to fill the post and its decision in this regard shall be final. The University may also increase or decrease number of advertised posts without prior notice.
10. The University reserves its right to place reasonable limit on the total number of candidates to be called for interview. Fulfilment of essential qualifications *per se* does not entitle a candidate to be called for interview.
11. Any change of address (permanent/correspondence) given in the application form should at once be communicated to the University.
12. The applicants are advised to list their proposed, ongoing and completed research projects.
13. The applicants serving in Government / Semi Government organization /Public Sector Undertaking / Autonomous organizations / Universities / Educational / Research Institutions must get the endorsement form filled by their employer and upload the same. The applications received without the recommendations of the employer will not be considered.
14. In case of in-service candidates from private sector, acceptance of resignation and relieving letter from the employer at the time of joining must be submitted.
15. The age of superannuation for all the posts shall be as per UGC / AICTE norms.
16. Candidates shall have to produce original documents for verification purposes at the time of appearing in interview.
17. Before applying for a post, candidates are advised to satisfy themselves about their eligibility.
18. Canvassing in any form may lead to cancellation of candidature.
19. The University shall verify the antecedents / documents submitted by the candidates at the time of appointment or any time during the tenure of the service. In case, it is detected that the documents submitted are fake or the candidate has a clandestine/background and has suppressed the said information, his / her services shall be terminated forthwith.
20. The University may draw reserve panel (s) against possible vacancies in future.
21. Incomplete applications / applications received without application fee and those received after due date, if prescribed, shall be liable to be summarily rejected without notice. However, University reserves the right to consider the applications received after such last date. In case the last date fixed for receiving the applications is declared a holiday, next working day shall be deemed to be the last date for receiving the forms.
