Eligibility Criteria: B.E./B.Tech. in Electrical Engineering with a minimum of 2nd class or equivalent in grade point average and having a work experience of 2-3 years in supervision of Electrical construction and maintenance / internal electrification preferably in a large construction company of repute or Universities having their own campus or Government / Semi-Government organizations.

2. **Workshop Operator [Fitter]** in the pay band of ₹.5200-20200 with GP of ₹.1900/-, revised to level 2 (19900-63200) as per 7th CPC.

Eligibility Criteria: Diploma in Mech. Engg. / Production Engg. with 02 years of experience in the relevant field OR Matriculation with ITI (in Fitting) & 05 years of experience in the relevant field in a reputed educational Institute /University / Workshop.

General Conditions

1. The medium of instruction in the University is English.
2. It is made clear to all applicants that the University's "Applications Short-listing Committee" will decide the short-listing criteria which may be much higher than the Minimum Eligibility Criteria laid down by the regulatory bodies.
3. The University reserves its right to place reasonable limit on the total number of candidates to be called for interview. Fulfilment of essential qualifications per se does not entitle a candidate to be called for interview.
4. The eligibility of the applicants shall be considered as on their date of application.
5. The Selection Committee reserves the right to relax criteria of eligibility in qualification and experience in case of highly deserving candidates or in exceptional cases.
6. University reserve the right to withdraw any advertised post at any time without assigning any reason thereof. The right is also reserved with the University either to fill or not to fill the post and its decision in this regard shall be final. The University may also increase or decrease number of advertised posts without prior notice.
7. Any change of address (permanent/correspondence) given in the application form should at once be communicated to the University.
8. The applicants serving in Government / Semi Government organization /Public Sector Undertaking / Autonomous organizations / Universities / Educational / Research Institutions must send their applications "Through Proper Channel". The applications received without the recommendations of the employer will not be considered.
9. In case of in-service candidates from private sector, acceptance of resignation and relieving letter from the employer at the time of joining must be submitted.
10. **Applications have to be filled online and an application fee of ₹.500/- has to be paid [via online mode].**
11. Candidates shall have to produce original documents along with a self-attested photocopy of all credentials, for verification purposes, at the time of appearing in interview.
12. Before applying for a post, candidates are advised to satisfy themselves about their eligibility.
13. Canvassing in any form may lead to cancellation of candidature.
14. The University shall verify the antecedents / documents submitted by the candidates at the time of appointment or any time during the tenure of the service. In case, it is detected that the documents submitted are fake or the candidate has a clandestine/background and has suppressed the said information, his / her services shall be terminated forthwith.
15. The University may draw reserve panel (s) against possible vacancies in future.

Incomplete applications / applications received without application fee and those received after due date, if prescribed, or those received without relevant supporting enclosures (self-attested copies of degrees/certificates/mark-sheets/experience certificates etc.) shall be liable to be summarily rejected without notice. However, University reserves the right to consider the applications received after such last date. In case the last date fixed for receiving the applications is declared a holiday, next working day shall be deemed to be the last date for receiving the forms.
