We are pleased to inform you that based on your performance in the selection process for admission in MBA Program 2020-22 held on 26.06.2020 and the details claimed by you in the application to the University, you are provisionally allotted a seat in the **Two Year Full Time Master of Business Administration (MBA) Program** offered by the **School of Business, (SoB)** Faculty of Management, Shri Mata Vaishno Devi University, for the Session **2020-21**. The admission is purely provisional subject to your meeting the eligibility criteria as mentioned in the Admission Brochure 2020 available on the University website www.smvdu.ac.in.

In case, you are found to have failed to meet the eligibility criteria as decided by the University on verification of relevant educational documents etc. latest by 17th August, 2020, your provisional admission offered by the University shall stand cancelled without any further communication from the University. However, candidates, who have appeared / are appearing in their qualifying examination and the regular examination results of which are yet to be declared will be required to submit the proof of having met the eligibility criteria latest by 15th September 2020 (the date may be extended beyond 15th September 2020, by the University, subject to prevailing conditions) failing which the admission granted will be withdrawn without any further communication.

It may be noted that the onus of ensuring that you are meeting the eligibility criteria is with you and if found ineligible at a later stage or if the information submitted by you is found incorrect at any stage, then the provisional admission granted shall be cancelled without any further communication.
