2. ***For candidates who have completed their Qualifying Degree:*** In case they fail to meet the eligibility criteria as mentioned above, on verification of relevant educational documents etc., their provisional admission offered by the University shall stand terminated without any further notice and the fee submitted will be forfeited.

3. ***For candidates who have appeared/are appearing in their qualifying examination and the regular examination results of which are yet to be declared:*** They will be required to submit the proof of having met the eligibility criteria latest by 15 September 2020 (the date may be extended beyond 15 September 2020, by the University, subject to prevailing conditions) failing which the admission granted shall stand terminated without any further notice and the fee submitted will be forfeited. In case the candidate obtains backlog/compartments or obtains less than 50% aggregate percentage after declaration of Regular Result and has deposited the fee prior to declaration of result then the whole fee deposited shall be refunded to the candidate after deduction of Rs. 1000/-, provided that the candidate had obtained 60% or more in the pre-final year of the qualifying degree.
