Eligibility : **A.** Educational Qualifications: First Class Bachelor's Degree in Architecture; OR Bachelor's Degree in Architecture AND First Class Master's Degree in Architecture.

B. Only candidates registered with Council of Architecture (COA) under the provisions of the Architects Act, 1972 shall be eligible. **C.** Work Experience (Excluding time spent for acquiring PG/Ph.D. qualifications): 01 year Teaching Experience as Regular/Visiting Faculty of Architecture. **D.** Those possessing Master's Degree shall be preferred.

General Conditions

1. The medium of instruction in the University is English.
2. The recruitment to the advertised post shall be carried out in accordance with the guidelines of the relevant regulatory authority.
3. It is made clear to all applicants that the University's "Applications Short-listing Committee" will decide the short-listing criteria which may be much higher than the Minimum Eligibility Criteria laid down by the regulatory bodies.
4. The University reserves its right to place reasonable limit on the total number of candidates to be called for interview. Fulfilment of essential qualifications per se does not entitle a candidate to be called for interview.
5. The eligibility of the applicants shall be considered as on their date of application.
6. University reserve the right to withdraw any advertised post at any time without assigning any reason thereof. The right is also reserved with the University either to fill or not to fill the post and its decision in this regard shall be final. The University may also increase or decrease number of advertised posts without prior notice.
7. Any change of address (permanent/correspondence) given in the application form should at once be communicated to the University.
8. The applicants serving in Government / Semi Government organization /Public Sector Undertaking / Autonomous organizations / Universities / Educational / Research Institutions must send their applications "Through Proper Channel". The applications received without the recommendations of the employer will not be considered.
9. In case of in-service candidates from private sector, acceptance of resignation and relieving letter from the employer at the time of joining must be submitted.
10. Candidates shall have to produce original documents for verification purposes at the time of appearing in interview.
11. Before applying for a post, candidates are advised to satisfy themselves about their eligibility.
12. Canvassing in any form may lead to cancellation of candidature.
13. The University shall verify the antecedents / documents submitted by the candidates at the time of appointment or any time during the tenure of the service. In case, it is detected that the documents submitted are fake or the candidate has a clandestine/background and has suppressed the said information, his / her services shall be terminated forthwith.
14. The University may draw reserve panel (s) against possible vacancies in future.
15. Incomplete applications / applications received without application fee and those received after due date, if prescribed, or those received without relevant supporting enclosures (self-attested copies of degrees/certificates/mark-sheets/experience certificates etc.) shall be liable to be summarily rejected without notice. However, University reserves the right to consider the applications received after such last date. In case the last date fixed for receiving the applications is declared a holiday, next working day shall be deemed to be the last date for receiving the forms.
