## **ORDER**

Whereas your firm submitted its offer in the form of Technical/Financial Bids in respect of various items/equipments in response to tender issued vide no. 01/SMVDU/2012-13/059 dated . 16.04.2013 for supply of various items/equipments in the School of Biotechnology, SMVD University.

Whereas after due scrutiny of Technical/Financial bids, your firm was found to be lowest in respect of Dissection Microscopes by the tender opening committee.

Whereas order for supply, installation, testing and commissioning of Dissection Microscopes was issued in favour of your firm vide order no. 94/SMVDU/S&P/SBT/SMVDSB/BY2013-14/1775-77 dated 28.03.2014 to deliver the item within thirty (30) days from the date of issuance of Purchase Order.

Whereas as per the above order you were required to deliver the said equipment by 28.03.2014.

Whereas in response to the above order, your firm requested for extension of delivery period upto 30.06.2014 vide letter no. KIPL/1/2014-15/256 dated 17.06.2014 and the same was allowed by the University vide letter no. SMVDU/S&P/2014/507-509 dated 25.06.2014 subject to the condition that all other terms and conditions mentioned in the supply/purchase order dated 28.03.2014 shall remain unchanged.

Whereas your firm instead of supplying the material within the extended delivery period, again requested for extension upto 15.07.2014 to dispatch the material and the same was again allowed by the University upto 22.07.2014 vide letter no. 94/SMVDU/S&P/SMVDSB/BY2013-14/582 dated 08.07.2014 subject to the condition that all other terms and conditions mentioned in the supply/purchase order dated 28.03.2014 shall remain unchanged.

Whereas instead of supplying the material within the aforesaid extended period, your firm expressed its inability to supply the same on the quoted rates vide letter no. KIPL/1/2014-15/784 dated 06.10.2014.

Whereas in view of failure to supply the ordered material (Dissection Microscopes), the supply order issued vide no. 94/SMVDU/S&P/SBT/SMVDSB/BY2013-14/1775-77 dated 28.03.2014 was cancelled and withdrawn vide no. 94/SMVDU/S&P/SBT/SMVDSB/BY2014-15/2196-2201 dated 29.01.2015 and it was also directed to Show-Cause as to why your firm be not blacklisted for all the future dealing with the University.

Whereas in response to the above, your firm submitted its reply to the Show-Cause vide letter no. KIPL/1/2014-15/1272 dated 03.02.2015 and the same was found to be Not-Satisfactory.

Consequent upon above, your firm is hereby **Blacklisted** for all future dealings with the University with immediate effect alongwith forfeiture of the Earnest Money Deposit (EMD) amounting to Rs 17,000/- (Rupees Seventeen thousand only) issued by Bank of India, Shakti Nagar, New Delhi vide FDR No. 8039722725 dated 01.05.2013.
