**Terms and Conditions to Auction Notice**

1. Scraps (Scraps in the form of students job of mild steel, metal chips etc ) will be sold to the highest bidder lying in central workshop on "As is where is basis".
2. The bidder(s) shall have to register themselves with SMVDU between 10 AM to 4:00PM & deposit their security in the shape of CDR/ FDR for an amount of Rs. 5000/- (Rupees Five Thousand Only) pledged to the Registrar, SMVDU, without which, no bidder shall be allowed to participate in the auction.
3. Bidders are advised to visit SMVDU in advance in order to well verse with the condition of material before coming to the auction.
4. The successful bidder will be required to deposit the bid value immediately after the bid is knocked down.
5. In case material is not removed from the premises of the SMVDU within one week from the date of auction, the amount deposited will be forfeited.
6. The SMVDU reserves the right to accept/ reject any bid (including highest bid) without assigning reason thereof.
7. The decision of the SMVDU authorities will be final.
8. The SMVDU may impose/ relax any condition and announce the same at the time of auction.
9. In case the successful bidder fails to deposit the bid amount within the stipulated time, their CDR/FDR shall be forfeited without assigning any reason.
