## Terms & Conditions:-

2. The ARC shall be valid for one year from the date of issuance of notification and inclusive of all taxes/ charges.

3. 100% payment shall be released after the execution of repair and submission of bill.

4. Warranty (on rewinding): 6 (six) months from the date of successful repair.

5. All the disputes are subject to jurisdiction in the court of law, Jammu in Jammu

6. In case of any dispute arising out of the supply order, the decision of the Arbitrator, who shall be nominated by the Vice-Chancellor SMVDU, shall be final and binding upon both the parties.

7. The party shall collect the defective fans from SMVDU Campus and handover the repaired fans back at the same place.
