

- 2. THE OTHER FOR THE HOSTEL RENT AS INDICATED AT S.NO. 5
- 3. THE THIRD FOR MESS CHARGES INDICATED AT S.No. 7

NOTE: STUDENTS ARE ADVISED TO DEPOSIT THE HOSTEL RENT PREFERABLY IN CASH DEPENDING UPON CHOICE AND AVAILABILITY OF OCCUPANCY.

# Fee under the head of Hostel Charges includes Electricity Charges of Rs. 1575/- per annum & water Charges of Rs. 157.5/- per annum. An escalation of 5% after every two years shall be applicable under all the heads viz Room Charges, Electricity Charges & Water Charges.

- > The Heads of Payment at S No. 2 & 3 above are applicable only to the New Students to be admitted in August, 2013 (both UG & PG programes)
- > The revised rates of Hostel Charges at S No. 5 above shall not be applicable to students of 2012 batch. They shall pay the Hostel Charges as per rates specified in the Prospectus for the year 2012. The applicability of revised rates of Hostel charges for them shall be in Academic Year 2014-15
