The complete report of antiplagiarism software of the Ph.D. thesis must accompany the certificate. (ii) For checking the plagiarism the similarity < 1% should continue to be excluded while generating the plagiarism report, as this provision is available in the plagiarism check software available with the University in lieu or generic terms, laws, standard symbols and standard equations etc. as suggested by the UGC. The above may be certified by the concerned Head of School, be sides the supervisor(s). Rest of the contents of R19 shall remain the same.
