 - i. The Bids shall be submitted in Electronic Format only through the website www.jktenders.gov.in from 29-09-2023(1600 hours) to 11-10-2023 up to 1500 hours.
 - ii Technical Bids of bidders shall be opened online on 13-10-2023 at 1500 hours.

- 3. Bid documents are available which can be downloaded from the website www.jktenders.gov.in Bid documents contain qualifying criteria for bidder, bill of quantities, conditions and other details.
- 4. Bids must be accompanied by EMD and proof of remittance of cost of tender document in f/o the **Registrar SMVDU** as specified in column 4 & 5 of the Table.
 - Financial Bids will be opened after opening of technical bid on any convenient date and time. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day.
- 5. The bid for the work shall remain open for acceptance for a period of 120 days from the date of opening of the bids.
- 6. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering and Administrative duties in an Engineering Department of State Government/ SMVD University is allowed to work as a contractor for a period of two years after his retirement from Institutions, without permission of the Competent Authority.
- 7. In case the work is not started within the prescribed time, the work shall automatically be treated as cancelled and no correspondence shall be made for the same and EMD will be forfeited without any notice.
- 8. Instructions to bidders regarding e-tendering process.
 - i. The interested bidder can download the NIT/bidding document from the website www.jktenders.gov.in.
 - ii. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This Certificate is required to sign the bid digitally. Bidders can get the above mentioned digital certificate from any of the approved vendors. The bidders, who already possess valid Digital Signature Certificate (DSC) need not to procure new Digital Signature Certificate.
 - iii. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal shall be accepted in physical form.
 - iv. Bids shall be opened online as per schedule mentioned in Part 2 (ii).
 - v. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with the bid.
 - vi. The Department will not be responsible for any delay in online submission of bids whatsoever reasons may be.
 - vii. All the required information for the bid must be filled carefully.
 - viii.Bidders should get ready with the scanned copies of cost of documents &EMD as specified in the tender documents. Tenders received without tender fee and EMD shall be summarily rejected.
 - ix. Proof of EMD /Tender Fee along with the Technical Bid has to be uploaded online on the e-tendering portal http://jktenders.gov.in.
 - 9. The bidder / contractor shall have to deposit EMD@ 2% of the quoted value in the University Bank A/c No. SB-0477040520000029, IFSC

JAKA0SMVDUN of J&K Bank Ltd. in favour of "SMVDU, which shall be released after successful completion of AMC period i.e. 01 year.

- 10. The successful bidder /contractor shall have to deposit performance security in any of the required forms(CDR/FDR/BG) for an amount equivalent to 3% of the contract price before award of contract, pledged to Registrar, Shri Mata Vaishno Devi University. The performance security shall be released after successful completion of AMC period i.e 12 months.
- 11. There is no need of furnishing of hard copies of bids after submission of e-tender. The same should be obtained only from the bidder who is declared as L1 after the opening of financial bid as per the instructions of Finance Department vide O.M. No. A/24(2017)-651 Dated 07-06-2018.
- 12. In case of tie, allotment of bids shall be decided in transparent manner as decided by the competent Authority.
- 13. The guidelines for submission of online bid can be downloaded from the website www.jktenders.gov.in.
- 14. Bidders (OEM / Dealers) must be recognized with Chief Lift Inspector (Mechanical) Division Jammu.

A. GENERAL INSTRUCTIONS FOR THE BIDDER

1. Qualification of the bidder

In order to qualify, all bidders shall upload the self-attested copies of following documents:-

- Self attested photo copy of registration card duly renewed for the current financial year 2023-24.
- b) Self attested photo copy of PAN Card.
- c) Self attested photocopy of GSTIN Registration/on and latest clearance certificate FORM GST-3B i.e. latest clearance certificate FORM GST-3B of the preceding Month to the Issued of NIT.
- d) Proof of deposition of Earned Money Deposit.
- e) Tender cost (Receipt mentioned the name of the work for which tender fee was deposited)
- f) Affidavit with nomenclature of work for correct information duly signed by the contractor/agency (As per Annexure-B).
- (g) The work is of essential nature and the contractor/firm/workmanship has at least 03 years of good experience for maintenance/Servicing of lifts and connected works.
- 2. Disqualification of the bidder(s), even though the bidder(s) meet (s) the above qualifying criteria, if they have:

- i) Made misleading or false information in the forms, statements, affidavits duly attested by magistrate and proof of the qualification requirements; and/or
- ii) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

3. Site Visit

The Bidder, at his own cost, responsibility and risk is encouraged to visit, examine and familiarize himself with the site of work(s) and its surroundings including source of building and obtain all information that may be necessary for preparing the Bid and entering into a contract for construction of the work(s). The site visit shall be at the bidder's own expenses. The bidder(s) may contact the Executive Engineer/ Engineer In charge of the work for any guidance relating to site visit.

B. BIDDING DOCUMENTS

(i). Content of bidding Documents

The set of bidding documents shall be:-

- (i) Notice Inviting Tender.
- (ii) Bill of Quantities.

(ii) . Amendment of Bidding Documents

Before the deadline for submission of bid the Employer may modify the bidding documents by issuing addendum.

To give prospective bidders a reasonable time to take an addendum into account in preparing their bids, the Employer shall extend, as necessary, the deadline for submission of bids.

(iii). Preparing of Bids

Language of the Bid is English only.

C. DOCUMENTS COMPRISING THE BID

The bid submitted by the Bidder(s) in electronic format shall be in two separate parts:-

PART I- The first part shall be named as Technical Bid which shall comprise of scanned copies of following documents:-

PART II- The second part shall be named as (BOQ) Financial Bid and will be a part of the same bid.:

D. BID PRICES

- (i) All duties taxes, royalties and other levies payable by the contractor under the contract, or for any other cause shall be included in the rates, prices and total bid price submitted by the Bidder.
- (ii) The rates and prices quoted by the Bidder shall be fixed for the duration of the contract.

SPECIAL CONDITIONS:-

- 1. The AMC is initially for one year and may be extended for further two years depending upon the performance of Agency/Bidder.
- 2. The contractor shall use spares parts as recommended by manufacturer and as per the existing company spares fitted in the KONE Make lifts.
- 3. Any item (not covered in scope of repair work) but deemed necessary for operation and safety of lifts shall be charged extra after prior approval of University authorities.
- 4. Any part replaced during repair work shall be warranted for a period of six months. AMC shall start after the Lifts made operational after repairs.

SCOPE OF WORK

The following routine check shall be carried out and all the deficiencies found shall be rectified and repaired by the Agency/contractor immediately during contract period.

ROUTINE AND PREVENTIVE MAINTENANCE

Program of routine and preventive maintenance during the tenure of annualmaintenancecontractshallcomplywithminimumrequirements as below.

Monthly

- To check all bearing oils, oil rings, oil chains, etc. All machines should be carefully checked and repaired for abnormal temperature rise.
- To check and repair all relays and contracts as well as their movements and repair as necessary.
- To check brake action and adjust if necessary.
- To check and test Automatic Rescue Device (ARD)
- To check and repair movement of door switches, gate switches and emergency stop switches.
- To check and repair indicator lamps and indicator.
- To check and adjust leveling differences, brake slippage, acceleration, deceleration and riding comfort.

- Toe clean ropes oil if necessary.
- To turn grease cups for speed governors and compensating pulleys.
- To oil all pins of door operation and door opening mechanisms.
- To clean and repair brake wheels and shoes.
- To oil electric brake pins.
- To clean interior of car control switches with vacuum cleaner.

Every Three months

- To check and test all safety devices and repair/replace, If required.
- To check and repair flexible cable.
- To clean and oil safety gears.
- To clean traction machines, relays panels, control panel, starter panels, selectors, governors, car top, car gates, sills and pits.
- To check and repair door shoe, movement of limit switches.
- To charge gear oil and motor oil, if necessary.
- To check and repair the operation of terminal limit switches and final limit switches, governor switches.
- To check and repair the traction ropes for broken wire, wear elongation and even tension. Adjust if necessary.
- To remove the dust inside the traction machines and controls panels using electric blower.
- To clean and repair the indicator lamps.
- To check the voltage of rectifiers and thrusters

Half Yearly

- To check and repair the operation of safety gears.
- To check oil for oil buffers, if necessary to be provided.
- To check and clean the hall buttons and contacts.
- To check and repair the compensating chains or ropes.
- To check and oil the bearing of door motors.
- To grease the secondary sheaves, car top sheaves and counterweights.
- To check the wear of guide shoes of cars and counterweights

Annually

- To clean the wire connection box of every landing and car cages. Tighten all screws and check the conditions of cables at conduit inlets and outlets.
- To check and repair the conditions of worm gear and thrust bearing of the gear boxes.
- To check and tighten screws of control panels, starters panels and relay panels.
- To remove the dust inside the landing indicator switches by electric blower.
- To dismantle, clean and adjust the electromagnetic brake of gearless machines.
- To charge gear oil and motor oil
- To check and tighten screws and foundation bolts of traction machine, secondary sheaves, exterior of lift frame, guide rail, guide rail clamps and bracket etc.
- To test the over current relays
- To provide all labor, materials, tools and transport to carry out annual inspection and load test according to the requirement of the employer.
 - All the scheduled maintenance services described above shall be properly programmed and agreed with the Engineer-in-charge in order not to affect operation of the lift systems and service provider will submit an report on 25th day

General Conditions:

- 1. The contractor cannot sublet the contract to any other agency without the approval of the Engineer-in-charge/Executive Engineer.
- 2. The contractor shall be bound to use the approved make and as per water purifier manufacturing company rates. Any item which is not covered in the advertised rate list, the specifications/make of the same is required to be recommended by the Engineer-in-Charge and approved by the Executive Engineer
- The contractor shall be responsible for inspection and testing of the installation of the site. The installation shall not be accepted until it complies with the requirement of the specifications
- 4. No conditional tenders shall be accepted but straight way rejected even though the rates quoted may be lowest
- 5. The rates quoted by the tenderer should be firm and will hold good for a period of three months from the date of opening for allotment purpose.
- 6. The tender opening committee reserves the right to reject any/ all the tenders without assigning any reason thereof.
- 7. In case of Firm/Contractor fails to start the work within the stipulated time, a registered notice or notices sent through special messenger to the Firm/Contractor for non start of the work that amounts to breach of the contract and will be sufficient to windup or cancel his contract.
- 8. The Department may execute the work left by the contractor at his risk and cost. Any additional amount involved for execution of work shall be recovered from the contractor's dues lying with the University.
- 9. The contractor shall be personally liable for civil and criminal prosecution under law, if specification of the work/materials used is found in contravention to the specifications prescribed during execution of work and even after completion and finalization of contract i.e. at any stage.
- 10. In case of delay in execution of work, a penalty up to 10% of the value of the work shall be imposed @ ½ % per week or part there of and the same shall be recovered from the contractor from any money due or which becomes due to him from the University.
- 11. The defective work will be rejected and got done through some other agency at the risk and cost of the contractor, in case the contractor fails to rectify the defects during the currency of the contract and defect liability period.

- 12. The contractor is required to complete the work in a time bound manner and within stipulated period of time of completion as advertised in the e-NIT and in no case an extension in time period for completion of work shall be granted beyond the time period specified.
- 13. The rates quoted shall hold good for the whole period of AMC and the AMC can be further extended to another year on mutually agreed term and conditions subject to the accord of approval of university authorities.
- 14. The bidder (s) are requested to go through the e-NIT thoroughly prior to submission of the bid.
- 15. The work will have to be executed strictly in accordance with the Engineering wing of SMVDU.
- 16. The contractor shall enter into a contract agreement with the SMVDU with in 15 days from the date of letter of award, the cost of stamp paper ,duty registration shall be borne by the Contractor.
- 17. All the materials shall be approved by the Engineer-In-charge whose decision shall be final and binding on the contractor.
- 18. No escalation shall be paid during the contract period for completion of the work on the quoted rates. Tools and tackles is in the scope of contractor for execution of job.
- The GST, Construction Workers Welfare Cess and other taxes leviable shall be recovered on the Govt. prescribed rates from time to time till completion of the project.
- 20. The firms/ contractors registered with the GST shall only be eligible to the cast the tender for the work.
- 21. In case of last date having declared as Gazetted Holiday, the next working day shall be considered as last date for receipt of tender.
- 22. The contractor will abide by all labour laws and will be personally responsible for any accident/casualty caused during the period of execution and completion of work.
- 23. In this contract nothing extra shall be paid on account of lead, lift & carriages etc. from source of supply to the site of work. The Contractors/firms are therefore required to visit the site of work and quote their rates accordingly.
- 24. The successful bidder L1 shall have to deposit an additional performance security in the shape of CDR/FDR/BG before award of contract in case the bid

of the successful bidder is found to be unbalanced and the following scale shall apply there to:-

Additional performance security shall be released after the successful completion of work.

- 26. In case the lowest bidder quotes higher rates than the estimated rates against any item mentioned in the BOQ, shall be paid at the estimated rates temporarily and the balance payment of these items (i.e. Quoted rates minus Estimated rates) shall be released after successful completion of the contract i.e. after executing all the items of work for which the lowest bidder quotes lower rates.
- 27. The contractor shall have no claim whatsoever for compensation or idle charges against SMVDU on any ground or for any reason.
- 28. The materials of the approved brands shall be used by the contractor for the work.
- 29. All terms and conditions of E-NIT/Agreement/Special conditions shall also part of the contract/agreement.
- 30. The watch and ward of all materials/machinery shall be the responsibility of contractor/executing agency.
- 31. Any repair, if required, to be got executed for defective work shall be done by the contractor at his cost during AMC Period.
- 32. **Time Extension**: Suitable Time extension shall be granted in case of increase in scope of work and in the event of delay beyond the control of contractor to be determined by the department.
- 33. Restoration of work:- On completion of contract, the contractor shall be responsible to remove all unused material, clearing of site and restore all work in its original condition at his own cost.
- 34. **Submission of Bills:-** The First running Bill will be submitted by the contractor after completion of 1st service and a subsequent follow up visit from the date of

- start of AMC and the 2nd and final bill after the successful completion of AMC period.
- 35. **Arbitration:** In case of any disputes arising out of the contract shall be referred to the Arbitrator i.e. Vice-Chancellor, SMVD University. The decision of the arbitrator shall be final and binding upon the parties concerned. The arbitration shall be conducted in accordance with the arbitration procedure stated in the Arbitration and Conciliation Act.1996 as amended from time to time.
- 36. **Safety:** The contractor shall be responsible for safety of all activities at site of work.
- Treasures & Fossils:- Anything of historical or other interest or of significant value unexpectedly found on the site shall be the property of the SMVD University (Works Department).
- 38. Termination of Contract: The Employer may terminate the contract, if the contractor causes a fundamental breach of the contract. Fundamental breach of contract will include:-
 - (i) Continuous stoppage of Work for a period of 30 days without authorization of Engineer in-charge.
 - (ii). Contractor is declared bankrupt
 - (iii) Any evidence of involvement of contractor in corrupt practices.
 - (iv) Contractor delays the completion of work beyond stipulated time of completion.
 - (v) Pursuant to the process of termination of contract, the University reserves the right to invite fresh tender for the balance work at the risk and cost of the defaulter/contractor.
 - (vi). In case contractor failed to start /complete the work, within the stipulated time period, his Earnest Money shall be forfeited without any further notices, besides, the defaulter shall be debarred to participate in tendering process at least for one year..
- 39. **Labour Laws:-** The following Major Labour Laws are strictly applicable to all the manpower engaged by the contractor:-

 - (xi) Industrial Employment standing orders Act 1946.
 - (xii) Trade Union Act 1926.
 - (xiii) Child Labour (Prohibition & Regulation) Act 1986.

- (xiv) Inter-state Migrant workmen's (Regulations of employment and conditions of service) Act 1979.
- (xv) The Building and other construction workers (Regulation of employment and condition of service) Act 1996.
- (xvi) Factories Act 1948.
- (xvii) Compliance with Labour Regulation Laws of J&K State.
- (xviii) Building & Construction Cess @ 1% to be paid to CEO, Jammu & Kashmir construction Welfare Board shall be deducted from the bills of the contractor.
- 40. **Insurance:-** The Labour/Machinery/Work/Plant Material/Equipment of the contractor should be covered under Insurance Plan.
- 41. Law Governing the Contract:- The contract shall be governed by Laws of the land.
- 42. **Court's Jurisdiction:** In case of any disputes/differences arises between the contractor and the University, the same shall be settled in jurisdiction of the Courts in Jammu District only and no other Court shall have the jurisdiction.
